DISCLOSURE AND AUTHORIZATION PERTAINING TO CONSUMER REPORTS PURSUANT TO THE FAIR CREDIT REPORTING ACT (FCRA), 15 USC §1681A

A required component of your application to become an agent of RoadOne LogisticSystems ("RoadOne") is an inquiry with a credit bureau. Under the provisions of the FCRA, RoadOne may not obtain the report unless:

- "a clear and conspicuous disclosure has been made in writing to the consumer at any time before the report is procured or caused to be procured, in a document that consists solely of the disclosure, that a consumer report, may be obtained for employment purposes"; and
- "the consumer has authorized in writing the procurement of the report by that person."

This <u>Disclosure and Authorization Pertaining to Consumer Reports Pursuant to the Fair Credit Reporting Act</u> must be signed so RoadOne can conduct an inquiry with a credit bureau and complete its investigation.

This authorization is valid for five (5) years from the signed date, or upon the termination of my agency agreement with RoadOne, or until RoadOne has completed its investigation, whichever is sooner. If another consumer/credit report is required by RoadOne, I understand that I will be required complete a new authorization.

Non-Disclosure Agreement

Both parties agree to keep confidential any and all verbal or written information concerning the Agent ("Agent") that is disclosed to us as RoadOne ("Company") that is deemed by the Agent to be confidential, as well as any information the Agent learns about RoadOne during the process. By signing this Agreement, we acknowledge that; (1) the Information which we have received and/or will receive from the Agent is confidential, to the extent the information is identified as confidential and is not available in the open market. Both parties agree that in the event one party violates this agreement then the other party shall be entitled to equitable relief, including injunction.

Neither party will use, or permit the use of, the Information in a manner that could be detrimental to the other party or for any purpose other than our evaluation of a transaction between both parties. RoadOne will not disclose the name of the Agent or any of the Information to any person other than our responsible officers or advisors. In addition, such Information will be disclosed only to the extent necessary to those of our advisors (1) who need to know such Information for the purpose of a transaction within the scope of this Agreement, (2) who are informed of the confidential nature of such Information, (3) who are directed to treat such Information confidentially and (4) who will sign and deliver to RoadOne, if so requested an agreement substantially in the form of this letter acknowledging the confidentiality of the Information.

Both parties agree that without the prior written consent of the other party, neither party will disclose or permit any of our officers, directors, employees or advisors to disclose to any person the fact that discussions or negotiations are taking place concerning the Agent & RoadOne.

We agree to return promptly to the Agent all original and duplicate copies of the Information, without retaining any copies, should our discussion terminate or at an earlier date if so requested by the Agent. The Information provided under this Agreement is the compilation of trade secrets belonging to the disclosing party. Both parties agree to indemnify and hold each other harmless from and against all losses, claims, damages, expenses and liability (including costs and attorneys' fees) which may incur and which arise out of actions, failures to act or statements made by the other relating to this Agreement. This agreement shall be governed and construed in accordance with the laws of the Commonwealth of Massachusetts.
